I. CALL TO ORDER

The meeting was called to order by President Nicholas W. Clavin, MD, on Saturday, November 11, 2023. The Vice President, Kristen Rezak, MD confirmed that a quorum was present.

II. APPROVAL OF MINUTES

A MOTION for approval of the Minutes of the Annual Business Meeting of the Society from October 8, 2022 at Pinehurst, was proposed, seconded, and approved by the Membership present.

III. REPORTS OF THE OFFICERS

President's Report – Nicholas W. Clavin, MD

Dr. Clavin thanked the NCSPS members for their support now and for the future of the Society. He acknowledged and thanked the Board for their support and knows moving forward we are in good hands.

President's Report – Kristen M. Rezak, MD

The past few years since the pandemic, our meeting registration has been a little lighter. This year we combined forces with VASPS which did come with a few challenges. We increased our room block to a higher level than our original contract and we just met the threshold not to have attrition. They had anticipated approximately 40 members from the Virginia Society attending the meeting but only had 19 register. We anticipated more assistance with marketing since ASPS manages VASPS. We decided to hold two resident sessions, one for NC and one for VA since both groups have their own awards, but this also took away a little time from the program. Overall the meeting came together nicely.

2024 NCSPS Treasurer's Report
